## OPCW's Mandate

The OPCW is an independent, autonomous international organisation with a working relationship with the United Nations.

The main function of the Organisation is to ensure the implementations of the provisions established in the Chemical Weapons Convention (CWC).



# OPCW's Responsibilities

OPCW assists the Conference of the States Parties and the Executive Council in the performance of their functions.

Some of these responsibilities are:

- ensuring the **chemical destruction** carried out as per the Convention;
- **verifying** the activities in the chemical industry;
- providing **international cooperation and assistance** for the State Parties;
- coordinating the maintenance of **emergency stockpiles** and **humanitarian assistance**;
- facilitating the **advocacy and educational outreach**.



# Procurement's Mission

Our objective is to procure goods and services to meet the requirement of users, this means getting our internal customer -

- the right product
  - at the right time
    - at the right place
      - at the right price
  
- Procurement functions include all actions necessary for the acquisition, by **purchase, rental or lease**, of property, including **products and real property**, and of **services**, including works and professional services in the form of consultancies, but excluding staff contracts.






## 2015 OPCW Procurement Value for Goods vs Services (in USD), exclude Syrian Operations






## 2015 OPCW Goods Purchases by Category (in USD)




