

# UNGM is the common procurement portal of the UN system



suppliers from all over the world

UNGM provides an excellent springboard for vendors to introduce their products and services to many UN organizations, countries and regions

UN market: \$18.6 billion in 2017

29 UN organizations use UNGM as their vendor database



98% of the total UN procurement spent

# 3 registration levels

Level is determined by the monetary value of potential contracts

# Basic registration

### Level 1 & 2



Provide your company name as written in the Certificate of Incorporation



Documents are provided in English or are officially translated into English



Ensure contact details are up-to-date



- Ensure the financial documents for the last 3y are provided



Log into your UNGM account frequently

Information can be checked by UN procurement officers



## **EXPRESS INTEREST**

Differentiate between tender notices requiring electronic submission through e-procurement systems and tender notices requiring hard-copy or email submission

Electronic submission through e-procurement systems

Response through traditional methods (hard-copy or email)
OR
Company is not registered with the agency


