#### **DESCRIPTION OF REQUIREMENTS**

The United Nations Office at Nairobi (UNON) on behalf of UN Environment Programme invites qualified Firms to participate in a prequalification process for the upcoming competitive tender process for Provision of In-country treatment of POPs Waste in Central Asia. This requirement involves piloting, optimization, supply and operation of a non-thermal destruction option in Central Asia.

#### 1. BACKGROUND:

With the objective of assisting countries in satisfying their obligations set out under the Stockholm Convention a project is being implemented in the Central Asian republics of Tajikistan and Kyrgyzstan . The aim of the project is the excavation, pre-treatment and irreversible transformation / destruction of 5000 metric tonnes of DDT and other POPs chemicals plus associated contaminated materials. Both countries currently have no suitable destruction technology to dispose of POPs waste in accordance with standards set out in the Basel and Stockholm Conventions.

In addition, geographic isolation (both are land locked) and inability to move waste across the Eurasian Customs Union countries mean that the option of export to a licensed facility operating outside the region are severely restricted. The exportation of 5000 metric tonnes of waste will also incur excessive transport costs plus the associated carbon footprint which needs to be considered as part of any submission proposed by the vendor. Consequently, UNEP in partnership with the Global Environment Facility (GEF) are providing the opportunity for technology vendors to propose the demonstration of equipment to effectively and efficiently address the challenges posed by this project in both countries. For the purposes of this demonstration a non-thermal treatment will be selected. The vendor will also be required to include all

necessary pre-treatment equipment to allow the processing of the waste using the selected technology.

The contract will be delivered in a series of phases. Each phase will have a discrete set of deliverables and milestones which must be met to allow progression to the next stage of the overall contract.

Phase 1: will trial the technology in a laboratory environment using pilot equipment and waste simulants to establish basic feasibility of destruction and define fundamental operational parameters such as power demand, destruction efficiency, water requirements, reagent costs, pre-treatment requirements. Detailed scope to be provided during the sesecutive solicitation excercise;

Phase 2: will define and test a pretreatment and waste handling mechanism to ensure the waste can be processed by the proposed technology. To include equipment specifications and supply of a single system plus trails on similar waste matrices to those found in both countries. Detailed scope to be defined in the consecutive solicitation excercise;

Phase 3: pilot scale operation of a complete system for pre-treatment and disposal using waste simulants. The vendor will also provide detailed specifications of preparatory ground works and services to be provided at the site of operation to allow for preparation prior to operations. This will be followed by deployment of the technology plus pre-treatment to one of the countries of operation;

Phase 4: demonstration of the technology deployed above in Phase 3 in one country of operation to include operational optimization in local conditions, training of operatives to run and maintain the equipment and provision of all site management and operational standard procedures in English and Russian. Supplier also required to provide a vented enclosure in which the treatment system will be housed to include dust suppression;

Phase 5: scale-up of deployment to allow for multiple processing lines at the site of operation. On-going technical support and annual maintenance and optimization of processing system. The scale up will be accompanied by the establishment of a solar array to offset energy demand for the operation of the facility

## 2. ASSIGNMENT OBJECTIVE

The primary objective is to conduct a demonstration of the capability of a non-thermal technology to destroy organochlorine pesticide wastes (such as the pesticide DDT) and associated heavily contaminated materials excavated from burial pits located at two ex-Soviet landfill/ polygon locations in the Central Asian republics of Kyrgyzstan and Tajikistan.

#### 3. SERVICES TO BE PROVIDED

The following services are to be provided:

#### Phase 1:

- Simulation of representative waste materials
- Laboratory / bench-top feasibility testing of a non thermal technology using the simulants
- Detailed performance monitoring of the destruction process using conventional laboratory technology at an ISO registered analytical laboratory
- Monitoring for potential by products of the process including dioxins and furans using conventional laboratory technology at an ISO registered facility

#### Phase 2:

- Design of a complete pre-treatment and waste handling regime for pre-processing of wastes to allow subsequent processing by the proposed technology;
- Supply and testing of pre-treatment regime with laboratory verification that the system produces homogenous waste feed suitable for processing by the proposed technology;

## Phase 3:

- Supply, assembly and testing of a single full size plant and associated equipment (back up power supply, pre-treatment and disposal technology) with full operational optimization.
- Testing on waste simulations in country of supply:

• Definition of all supporting ground works and utility requirements for supply at locations of operation;

#### Phase 4:

- Deployment of complete system and additional equipment to country of operation;
- Commissioning of complete system;
- Optimization of operating system;
- Training of local operatives;
- Supply of all finalized manuals and procedures in English and Russian;
- Operation of facility for 3 months with handover to local team;
- 6-month supervision of operations via periodic site visits;

#### Phase 5:

- Provision of servicing and planned maintenance;
- Scale-up of operations and supply of additional processing / pre-treatment units as required;
- Provision of power off-set solar array.

#### SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

The purpose of this EOI is to pre-qualify potential vendors who will be invited to participate in the upcoming tender exercise. Below is the criteria that will be used to pre-qualify the Vendors:

- 1. Vendors have Intellectual Property over a proven (commercially available) non-thermal treatment process (for destruction of POPs wastes) or have operated said technology under license or as an authorized supplier;
- 2. Vendors have deployed said technology under field conditions and operated the technology successfully to destroy POPs or similar wastes;
- 3. Vendors have experience in three separate projects on developing bespoke solutions under a variety of conditions to meet the specific needs of clients, to include waste handling and pre-treatment;
- 4. Vendors are able to provide a testimonial from 3 former clients for the above works described.
