*** Shipment & Additional Requirements:**

- Where the Successful Bidder is required to ship the relevant goods/products to West Bank, it will commence the delivery process only when UNOPS has provided an official request for delivery.

- To facilitate the delivery process, UNOPS will provide assistance in obtaining the relevant Israeli tax and custom duties exemption. UNOPS will not, however, assume any liability or risk where the Israeli Authorities do not, for any reason, provide such tax and customs duties exemptions.
- The Successful Bidder will furthermore assume all liability and risk related to the approval or clearance of the goods/products by the Coordinator of Governments Activities in the Territories (COGAT). In this respect, the Successful Bidder is responsible for all other costs associated with the delivery, including but not limited to any costs for storage (i.e. at port), customs brokers and transportation, product variations and currency fluctuation.
- The Successful Bidder will be responsible to provide a complete specification sheet of the vehicle together with any documents requested by COGAT.
- Supplier will be committed to provide UNOPS with the Chassis and Engine number of the vehicles within 4 calendar weeks from the day of signing the Purchase Order (PO).
- Delivery of the vehicle will be governed by INCOTERM 2010 DAP (Delivery at Place) to Ramallah, Israel within 4 calendar weeks from the date of receiving the customs and tax exemptions from UNOPS.
- Under reasonable circumstances, and justification provided by bidder, UNOPS MAY conditionally allow advanced payment up to 100 % of the total Contract amount, with an advance receipt of irrevocable guarantee made in favour of UNOPS from a bank in the form of a Bank Guarantee and commitment letter for the supply and delivery of the pickup vehicle.
- The Successful Bidder must have physical presence or local representative available in the country (West Bank) for after-sales service.
