- 6. UNFPA requires free, non-returnable product samples for evaluation of the item at the time of bid submission, i.e., Thursday, 5 April, 2018, at 15:00 Nepal time. Samples shall be considered as part of the offer and shall be subject to technical review and laboratory analysis, where appropriate.
- 7. The bid shall be opened on **Friday**, 6 **April**, 2018, at 11:00 **AM** at UNFPA Country Office, Jhamsikhel, Lalitpur. Bidders or their authorized representatives may attend the bid opening. Kindly confirm by e-mail by 26 March, 2018, whether your company shall be represented at the bid opening.
- 8. Bids received after the stipulated date and time shall not be accepted under any circumstances. Bids delivered through courier and posted later than the due date shall not be registered and shall be returned unopened or shall be shredded. Bids submitted to any other email address than bid.nepal@unfpa.org, shall be rejected.

#### **SECTION I: Instructions to Bidders**

#### A. Introduction

#### 1. Scope

- 1.1. The goods to be procured are **Dignity Kits** and **Kishori Kits** for UNFPA's Programme located in Nepal.
- 1.2. As a result of this bidding process, UNFPA shall sign non-exclusive Long Term Agreement (LTAs) with one or multiple vendors for two years with a possible 1 year extension based on supplier's good performance.

In the event of UNFPA signing long term agreements, the following shall apply:

- a. The successful Bidder(s) shall accord the same terms and conditions to any other organization within the United Nations System that wishes to avail of such terms, after written consent from the UNFPA Nepal Country Office;
- b. The agreements shall be valid for 2 years starting from the date the LTA was signed with a possibility of further 1 year extension.
- c. The quantities specified in Section II, Schedule of Requirements may not be reached or may be exceeded during the period of the agreement.
- d. The successful Bidder agrees to supply the Goods and Services to all the developing countries, least developed countries and transition countries listed in the following link: <a href="http://unstats.un.org/unsd/methods/m49/m49regin.htm#developed">http://unstats.un.org/unsd/methods/m49/m49regin.htm#developed</a>
- e. The long term agreement template as specified in Section VI, Contract Forms, 3, shall be used for the establishment of the final agreement.
- f. UNFPA will not be committed to purchase any minimum quantity of the goods and related Services, and purchases will be made only, if and when, there is an actual requirement. UNFPA shall not be liable for any cost in the event that no purchases are made under any resulting LTA. All reductions in market prices mandated by the provider will be passed on in full to UNFPA.
- g. Upon the establishment of LTA with successful Bidder(s), the following secondary bidding procedures will be followed each time there is a requirement for the Goods and Related Services:
  - i. A Request for Quotation (RFQ) will be sent to those firms with whom an LTA has been signed for the required goods/services.
  - ii. Bidder(s) will be required to provide their best FCA and CPT prices (for Goods) / prices (for Services), bearing in mind that the FCA prices (for Goods) / prices (for Services) cannot exceed the maximum ceiling unit prices quoted in response to this ITB.
  - iii. Quotations will be evaluated on the lowest prices. UNFPA reserves the right to either purchase CPT or FCA to nearest airport/port and to contract the freight component separately, whichever combination is in the best interest of UNFPA.
  - iv. Bidder(s) will normally be given 3 business days to provide a quotation. Depending on the complexity of the order and the destination, more time may be given.
  - v. UNFPA reserves the right to accept all or part of the bid.
  - vi. In order for UNFPA to request separate freight quotes from shipping companies, Bidder(s) will be required to include accurate shipping weights, volumes, dimensions and numbers of containers and of pallets in their quotations. Should there be any major discrepancies between the shipping dimensions quoted in the

- offer in response to the RFQ and the actual shipping dimensions, those quoted in the Bidder(s) offer in response to the RFQ will prevail.
- vii. Depending on the quantities being requested at the secondary bidding stage or the complexity of the case, Bidders may be requested to provide a performance security.
- viii. The successful Bidder(s) may be requested to quote for Goods and Related Services not listed in the LTA.

Bidder(s) invited to a secondary bidding, but who systematically do not respond regularly to UNFPA RFQs without valid justification may not continue to be invited to submit quotations.

#### 2. Eligible Bidders

- 2.1. All Bidders found to have a conflict of interest shall be disqualified. Bidders may be considered to have a conflict of interest if they are or have been associated in the past, with a firm or any of its affiliates that have been engaged by UNFPA to provide consulting services under these bidding documents.
- 2.2. Bidders shall not be eligible to submit a bid if at the time of bid submission:
  - a. The Bidder is listed as suspended on United Nations Global Marketplace (http://www.ungm.org) as a result of having committed fraudulent activities,
  - b. The Bidder's name is mentioned in the <u>UN 1267 list</u> issued by the Security Council resolution 1267 that establishes a sanctions regime to cover individuals and entities associated with Al-Oaida and/or the Taliban;
  - c. The Bidder is debarred by the World Bank Group.

#### **Fraud and Corruption**

3.1 UNFPA's policy regarding fraud and corruption is available at <a href="http://www.unfpa.org/about-procurement#FraudCorruption">http://www.unfpa.org/about-procurement#FraudCorruption</a> and applies fully to this Invitation to Bid. The submission of any offer implies that the Bidder is aware of this policy.

#### **B.** Solicitation Documents

#### 4 UNFPA Solicitation document

- 4.1. Bidders are expected to examine all instructions, forms, specifications, terms and conditions contained within this UNFPA solicitation document. Failure to comply with these documents shall be at the Bidder's risk and may affect the evaluation of the bids, or may result in the rejection of the bid.
- 4.2. Bidders are cautioned to read the specifications carefully (see Section II Technical Specifications and Schedule of Requirements), as there may be special requirements. The technical specifications presented herein are not to be construed as defining a particular manufacturer's product. Bidders are encouraged to advise UNFPA if they disagree.
- 4.3. The specifications are the minimum requirements for the products and related services. Products and services offered must meet or exceed all requirements herein. The products shall conform in strength, quality and workmanship to the accepted standards of the relevant industry.

Modifications of or additions to basic standard products of less size or capability to meet these requirements will not be acceptable.

#### 5 Clarifications of solicitation document

5.1 A prospective Bidder requiring any clarification on the bid solicitation documents may notify UNFPA in writing within one week from the date of issue of the bid. UNFPA shall respond in writing to any request for clarification received and circulate its response (including an explanation of the query but without identifying the source of enquiry) to all prospective Bidders who have received the bid solicitation documents. A copy of UNFPA's answer shall also be posted on the UN Global Marketplace, <a href="http://www.ungm.org/">http://www.ungm.org/</a> and UNFPA Nepal website <a href="http://nepal.unfpa.org">http://nepal.unfpa.org</a>.

#### 6 Amendments to UNFPA bid solicitation document

- 6.1. At any time prior to the deadline for submission of bids, UNFPA may for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, modify the bidding documents by amendment.
- 6.2. All prospective Bidders that have received the bidding documents shall be notified in writing of all the amendments to the bidding documents. In order to give prospective Bidders reasonable time to take the amendments into account in preparing their bids UNFPA may, at its discretion, extend the deadline for the submission of bids.

## C. Preparation of Bids

#### 7 Documents to be submitted with the bid

#### 7.1. Documents Establishing the Eligibility of the Bidder

To establish their eligibility, Bidders shall:

- a. Complete the Bid Submission Form, Section V, 2.
- b. Complete Bidders Identification Form, Section V, 3.

#### 7.2. Documents Establishing the Qualifications of the Bidder

To establish its qualifications, the Bidder shall submit to UNFPA's satisfaction the following documents:

- a. Evidence that the Bidder is established as a company and legally incorporated in the country where it resides; e.g. through provision of certification of incorporation or other documentary evidence (this is not required for companies already registered in national, regional or international Stock Exchanges);
- b. Post qualification documentation outlined in Instructions to Bidders, Sub-Clause 27

Failure to furnish all the information required for submission shall be at the Bidder's risk as it may then be determined that the bid does not substantially respond to the UNFPA bid document in every respect. This may result in a rejection of the bid.

# 7.3. Documents Establishing the Eligibility and Conformity of the Goods and Related Services Bidders shall submit:

- a. Documentary evidence that the goods conform to the Technical Specifications and standards specified in Section II Technical Specifications and Schedule of Requirements.
- b. Completed Product Item Overview Form, Section V, 4.

- c. Product catalogues containing pictures of the product(s)
- d. Manufacturer's technical product specifications or datasheets
- e. Results of any testing carried out on the products
- f. Copies of current certificates such as GMP/quality, FSC/CPP, manufacturer's ISO certificate for the product, manufacturer's CE certificate, USA 510k, Japan QS standard, etc., as stated in the Technical Specifications and Schedule of Requirements Section II
- g. The Bidder shall also furnish a list giving full particulars, including available sources and current prices of spare parts, special tools, etc., necessary for the proper and continuing functioning of the goods during 3 years following commencement of the use of the goods by UNFPA. Bidders must complete and submit with their bid the Excel table containing the individual item details, as per Form in Section V.4. Bidding Forms.

#### **8** Bid Currency and Prices

- 8.1. All prices shall be quoted in NPR (Nepali Rupees) or USD.
- 8.2. Bidders are requested to quote the following based on INCOTERMS 2010 (The terms FCA, CPT and other similar terms shall be governed by the rules prescribed in the INCOTERMS 2010, published by the International Chamber of Commerce):
  - Price of goods FCA Point of departure
- 8.3. Where installation, commissioning, training or other similar services are required to be performed by the Bidder, the Bidder shall include an itemized list of the prices for those services.

#### 9 Validity of Bid

- 9.1. The prices of the bid shall be valid for **90 days** after the closing date of bid submission as specified by UNFPA. A bid valid for a shorter period shall be rejected by UNFPA on the grounds that it is non-responsive.
- 9.2. In exceptional circumstances, UNFPA may solicit the Bidder's consent for an extension of the period of validity under exceptional circumstances. The request and the responses shall be made in writing.

#### 10 Bidders' conference

- 10.1 A Bidders' conference may be conducted at UNFPA's discretion. All Bidders will be encouraged to attend. Non-attendance, however, will not result in disqualification of an interested Bidder. Minutes of the Bidders' conference will be both posted on UNGM and e-mailed to the Bidders that have participated in the Conference. Verbal statements made during the Bidders' conference will not modify the terms and conditions of the ITB, unless issued as an amendment to the Bid documents and posted on UNGM.
- 10.2 A bidder's conference will be held on 15 March, 2018 at 14:00 UNFPA Nepal Country Office Conference Room to inform the nature and scope of work, implementation modality and experience and expertise required to complete the assignment. All interested bidders are requested to attend the meeting.

#### D. Submission of Bids and Bid Opening

#### 11 Partial Bids

10.1. Partial bids are **not allowed**, under this tender.

#### 12 Alternative Bids

- 11.1. Alternative bids will not be accepted. In the event of a supplier submitting more than one bid, the following shall apply:
  - a. All bids marked alternative bids will be rejected and only the base bid will be evaluated.
  - b. All bids will be rejected if no indication is provided as to which bids are alternative bids.

#### 13 Bids

- 12.1. Bids shall be submitted in one envelope or transmitted in an email to a secure email address designated by UNFPA.
- 12.2. Bids shall be prepared in accordance with Section II: Schedule of Requirements and Technical Specifications and shall include the requested documentation as per Instructions to Bidders Clause 7, and in in accordance with the Price Schedule Form in Section V, 5 of the bid forms.
- 12.3. Bids shall be signed by the Bidder or a person or persons duly authorized to bind the Bidder to the contract. A bid shall contain no interlineations, erasures, or overwriting except as necessary to correct errors made by the Bidder. In that case such corrections shall be initialled by the person or persons signing the bid.

#### 14 Sealing and Marking of Bids (hard copies)

- 13.1. When submitting bids in hard copies the Bidder shall prepare one set of sealed bids containing the technical and price components.
- 13.2. The envelope shall also indicate the name and address of the Bidder to enable the bid to be returned unopened in case it is declared "late."
- 13.3. If the outer envelope is not sealed and marked as required, UNFPA shall assume no responsibility for the bid's misplacement or premature opening.
- 13.4. The outer envelope must be clearly marked with the following:

#### 15 Electronic Submissions

- 14.1. Bids may be submitted electronically. Please note the following guidelines for electronic submissions:
- 14.2. Bidders shall make clear reference to the specific bid in the subject field as instructed, otherwise bids may be rejected. Clearly specify the following text in the subject line: ITB No. UNFPA/NPL/18/001, Bidder's Name.
- 14.3. The bid shall be submitted to <a href="mailto:bid.nepal@unfpa.org">bid.nepal@unfpa.org</a>. Bids received at the <a href="mailto:bi
- 14.4. E-mail submission shall not exceed 10 MB, including the size of the cover email. It is recommended that all the bidding documents are consolidated into as few attachments as possible which shall be in commonly used file formats. If the bid consists of large electronic files, it is recommended to send these files separately before the deadline indicating the order of emails (email 1, email 2, etc.) after the bid reference number and the Bidder's name in the subject line of each email.
- 14.5. It shall be the Bidder's responsibility to ensure that bids sent by e-mail are received by the deadline. All Bidders shall receive an auto-reply acknowledging the receipt of their email. Bidders shall not receive responses to questions sent to <a href="mailto:bid.nepal@unfpa.org">bid.nepal@unfpa.org</a> since it is a secure mailbox.
- 14.6. In order to avoid last minute internet congestion it is recommended to send your bid as early as possible before the deadline.

#### 16 Bid Submission Deadline/Late Bids

- 15.1. Bids must be delivered to the office on or before the date and time specified in the introductory letter of this solicitation document. If any doubt exists as to the time zone in which the bid should be submitted please refer to <a href="https://www.timeanddate.com/worldclock">www.timeanddate.com/worldclock</a>, or contact the bid focal point.
- 15.2. UNFPA may, under special and exceptional circumstances, extend the bid submission deadline and such changes shall be notified in UNGM before the expiration of the original period.
- 15.3. Any bid received by UNFPA after the bid submission deadline shall be rejected and returned unopened to the Bidder. UNFPA shall not be legally responsible for bids that arrived late due to the Bidder's problems with transmission of bid submissions via email and/or with the courier company.

#### 17 Storage of Bids

16.1. Bids received prior to the deadline of submission and the time of opening shall be securely kept unopened until the specified bid opening date stated in the UNFPA's solicitation document. No responsibility shall be attached to UNFPA for prematurely opening an improperly addressed and/or identified bid.

#### 18 Bid Opening

17.1. UNFPA shall conduct the bid opening in public at the following address, date and time.

- 17.2. Bids received electronically by the required deadline will be printed and a copy of the bids will be put in a sealed envelope that will be opened at the time and date specified in the bid document. Only the last received bid will be opened if multiple bids are sent by a same Bidder.
- 17.3. The bids shall be opened publicly at the time and place specified in the ITB and an immediate record made thereof.
- 17.4. Only those who have submitted bids or their authorized agent or representative may attend the bid opening.
- 17.5. The report shall be available for viewing by Bidders for a period of thirty days from the date of the opening. No information that is not included in the bid opening report can be given to Bidders.
- 17.6. No bid shall be rejected at bid opening, except for late bids, which shall be returned unopened to the Bidder.

#### E. Evaluation and Comparison of Bids

#### 18. Confidentiality

- 18.1. Information relating to the examination, evaluation, comparison, and post-qualification of bids, and recommendation of contract award shall not be disclosed to Bidders or any other persons not officially concerned with such process until the contract award is published.
- 18.2. Any effort by a Bidder to influence UNFPA in the examination, evaluation, comparison, and post-qualification of the bids or contract award decisions may result in the rejection of its bid.

#### 19. Clarification of Bids

19.1. To assist in the examination, evaluation and comparison of bids, UNFPA may ask Bidders for clarification of their bids. The request for clarification and the response shall be in writing by UNFPA and no change in price or substance of the bid shall be sought, offered or permitted.

#### 20. Responsiveness of bids

- 20.1. UNFPA's determination of a bid's responsiveness is to be based on the contents of the bid itself.
- 20.2. A substantially responsive bid is one that conforms to all the terms, conditions, and specifications of the bidding documents without material deviation, reservation, or omission. A material deviation, reservation, or omission is one that:
  - a. affects in any substantial way the scope, quality, or performance of the goods and related services specified in the contract; or
  - b. limits in any substantial way, inconsistent with the bidding documents, UNFPA's rights or the Bidder's obligations under the contract; or
  - c. if rectified would unfairly affect the competitive position of other Bidders presenting substantially responsive bids.

#### 21. Nonconformities, Errors, and Omissions

- 21.1. Provided that a bid is substantially responsive:
  - a. UNFPA may waive any non-conformities or omissions in the bid that do not constitute a material deviation.
  - b. UNFPA may request that the Bidder submit the necessary information or documentation within a reasonable period of time to rectify non material non conformities or omissions in the bid related to documentation\_requirements. Such omission shall not be related to any aspect of the price of the bid. Failure of the Bidder to comply with the request may result in the rejection of its bid.
  - c. UNFPA shall correct arithmetical errors on the following basis:
    - If there is a discrepancy between the unit price and the line item total that is obtained by multiplying the unit price by the quantity, the unit price shall prevail and the line item total shall be corrected, unless in the opinion of UNFPA there is an obvious misplacement of the decimal point in the unit price. In that case the line item total as quoted shall govern and the unit price shall be corrected;
    - if there is a discrepancy between words and figures, the amount in words shall prevail;
    - if there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and

#### 22. Preliminary examination of Bids

22.1. UNFPA shall examine the bids to determine whether they are complete, that all documents and technical documentation requested as per Instructions to Bidders Clause 7 have been provided and to determine the completeness of each document submitted. UNFPA will also examine whether any computational errors have been made, whether the documents are properly signed, and whether the bids are generally in order.

#### 23. Examination of Terms and Conditions and Technical Evaluation

23.1. UNFPA shall examine the bid to confirm that it does not contain any material deviations, reservation, or omission related to the conditions and requirements specified in the Section II Technical Specifications and Schedule of Requirements, Section III UNFPA General Conditions of Contract and Section IV UNFPA Special Conditions for Contracts.

23.2. If after the examination of the terms and conditions and the technical evaluation UNFPA determines that the bid is not substantially responsive in accordance with Instructions to Bidders Clause 21, the bid shall be rejected.

#### 24. Conversion to Single Currency

24.1. To facilitate evaluation and comparison, UNFPA will convert all bid prices expressed in the amounts in various currencies in which the bid prices are payable to US dollars at the official UN exchange rate on the last day for submission of bids.

#### 25. Evaluation of Bids

25.1. UNFPA shall evaluate each bid that has been determined, up to this stage of the evaluation, to be substantially responsive.

#### 26. Comparison of Price Bids

- 26.1. UNFPA shall compare all substantially responsive bids to determine the lowest priced substantially responsive bid
- 26.2. Bid comparison will be made on the total cost, delivered to final destination. UNFPA reserves the right to compare freight prices of Bidders with rates of reputable freight forwarders and to consider such rates for the purpose of bid evaluation. In the event that Bidder's freight prices are found to be less competitive than the rates offered by freight forwarders, UNFPA may issue a contract on FCA basis to the Vendor instead of CPT/CFR, and issue a separate contract for freight to a freight forwarder if deemed in the best financial interest of UNFPA.

#### 27. Post-qualification of the Bidder

- 27.1. UNFPA shall determine to its satisfaction whether the Bidder with the lowest priced, substantially responsive bid is qualified to perform the contract satisfactorily.
- 27.2. The determination shall be based upon an examination of the documentary evidence of the Bidder's qualifications submitted in the bid.
- 27.3. To evaluate a Bid, UNFPA shall consider the following:
  - Copy of last year audited company Balance and Financial Statements
  - Copy of valid manufacturing license from the country of manufacturing and/or a copy of company registration in the country of operation demonstrating that is duly authorized to supply these goods to the country of destination
    - Financial Capability:
      - a. Liquidity ratio: Current ratio (Current Assets/ Current liabilities) > 1.
      - b. Provide contact details of commercial banks and names of contact persons from whom UNFPA could seek feedback.
    - Experience and Technical Capacity:
      - a. Details of experience and past performance of the Bidder on equipments offered and on those of similar nature within the past three years
      - b. The Bidder shall disclose instances of previous past performance that may have resulted in adverse actions taken against the Bidder and the manufacturers whose

products are being offered by the Bidder, in the last five years. Such adverse actions may be treated as unsatisfactory performance history while deciding the award of contract. If no instance of previous past performance has resulted into adverse actions, this must be clearly indicated in the Bidder's bid.

#### For non manufacturer Bidders:

- a. Legally enforceable authorization from the manufacturer assuring full guarantee and warranty obligations as per the tender conditions for the goods offered; and
- b. The Bidder, as authorized by the manufacturers, has supplied and provided after sales service for similar goods to the extent of at least 20 percent of the quantities indicated in the tender requirements in any one of the last three years, and the goods must be in satisfactory operation.
- 27.4. Notwithstanding anything stated above, UNFPA reserves the right to assess the Bidder's capabilities and capacity to execute the contract satisfactorily before deciding on award.
- 27.5. Even though the Bidders may meet the above qualifying criteria, they can be subject to disqualification if they have made misleading or false representations in the forms, statements and attachments submitted in proof of the qualification requirements, and/or record of poor performance such as, not properly completing contracts, inordinate delays in completion, litigation history, financial failures, etc.

#### 28. UNFPA's Right to Accept Any Bid and to Reject Any or All Bids

- 28.1. A bid that is rejected by UNFPA may not be made responsive by the Bidder by correction of the non-conformity. A responsive bid is defined as one which conforms to all the terms and conditions of the UNFPA's bid solicitation documents without material deviations. UNFPA shall determine the responsiveness of each bid against the UNFPA solicitation documents.
- 28.2. UNFPA reserves the right to reject any bid if a Bidder has previously failed to perform properly or complete on time in accordance with contracts or the Bidder who in UNFPA's perspective is not in a position to perform the contract.
- 28.3. The Bidders waive all rights to appeal against the decision made by UNFPA.

#### 29. UNFPA's Right to Annul a Bidding Process

29.1. UNFPA reserves the right to annul the bidding process and reject all bids at any time prior to award of purchase order, without thereby incurring any liability to the affected Bidder(s) or any obligation to provide information on the grounds for UNFPA's action.

#### F. Award of Contract

#### 30. Award Criteria

- 30.1. In the event of a contract award, UNFPA shall award the Long Term Agreement to the lowest priced Bidder(s) whose bid has been determined to be substantially responsive with the bidding documents.
- 30.2. UNFPA reserves the right to award the LTA to more than one bidder whose bid complies with all the conditions and technical specification of this invitation to bid.
- 30.3. Bidders are to send samples of the requested products to the UNFPA in Nepal via an international air courier service by the **bid submission deadline i.e. Monday, 2 April, 2018, at 15:00 Nepal time**. The cost for sending the samples will be at the charge of the Bidder.
- 30.4. If required, the Bidder shall permit UNFPA representatives access to their facilities at any reasonable time to inspect the premises that shall be used for the production, testing and packaging of the products. The Bidder shall also provide reasonable assistance to the representatives for such inspection, including copies of any test results or quality control reports as may be necessary. UNFPA may inspect the manufacturing facilities of the lowest evaluated responsive Bidder to assess his capability to successfully perform the contract as per the terms and conditions specified in the ITB.
- 30.5. UNFPA reserves the right to make multiple arrangements for any item(s) where, in the opinion of UNFPA, the lowest Bidder cannot fully meet the delivery requirements or if it is deemed to be in UNFPA's best interest to do so. Any arrangement under this condition shall be made on the basis of the lowest, second lowest, third lowest, etc., bid which meets the requirements.

#### 31. Right to Vary Requirements at Time of Award

31.2. UNFPA reserves the right at the time of award of contract to increase or decrease by up to 20% the quantity of goods specified in this bid without any change in unit price or other terms and conditions.

#### 32. Signing of the contract

32.1. Prior to the expiration of the period of bid validity, UNFPA shall send the successful Bidder the **Long Term Agreement**, which constitute the notification of award. The successful Bidder shall sign, date the contract and return it to UNFPA within 10 days of receipt of the contract. After receipt of the contract, the successful Bidder shall deliver the commodities in accordance with the quantity, quality and delivery schedule outlined in its bid in conjunction with UNFPA terms and conditions.

#### 33. Publication of Contract Award

- 33.1. UNFPA shall publish the contract award on United Nations Global Marketplace <a href="http://www.ungm.org">http://www.ungm.org</a>, with the information of the awarded Bidder company name, contract amount or LTA and the date of the contract.
- 33.2 Suppliers perceiving that they have been unjustly treated in connection with the solicitation or award of a contract may lodge a complaint directly with the UNFPA Head of Office at

baqi@unfpa.org. The UNFPA Head of Office will then make an assessment of the complaint and provide a reply to the supplier within a week. If the supplier is not satisfied with the reply provided by the UNFPA Head of Office, the supplier may escalate the complaint to the Chief, Procurement Services Branch at <a href="mailto:procurement@unfpa.org">procurement@unfpa.org</a>, who will reply to the supplier within a week and advise the Supplier on further recourse if required.

#### 2.1.Term of Reference (TOR) for LTA to Procure Dignity Kits

#### **Background**

UNFPA is working in Nepal since 1971, and the current Eighth Country Programme (CP-8, 2018-2022) is aligned with the priorities of the Government's interim development plan and sectoral strategies. The CP-8 focuses on sexual and reproductive health & reproductive rights, youth and adolescent development, gender equality and women's empowerment and population data for development including humanitarian programme.

UNFPA is mandated by the United Nations to advocate for the right of every women, girls and man to enjoy a life of health and equal opportunity. UNFPA supports countries in using population data for policies and programmes, to reduce poverty and to ensure that every pregnancy is wanted, every birth is safe, and every young person's potential is fulfilled. During an emergency (whether man-made or natural), pregnancy related deaths and sexual violence soar. UNFPA responds in development, transition and emergencies to protect the rights of every woman, girls and man to relieve their sufferings.

In Nepal, UNFPA's major partners are the Ministry of Health (MoH), Ministry of Federal Affair's and Local Development (MoFALD), Ministry of Women, Children and Social Affairs (MoWCSW), the Central Bureau of Statistics (CBS), and various NGOs, including Nepal Red Cross Society (NRCS). UNFPA also coordinates with Ministry of Home Affairs (MoHA, the nodal Ministry for disaster response for disaster preparedness and response at national and sub-national level.

UNFPA, as a member of the Inter-Agency Standing Committee (IASC) has been leading Reproductive Health (under the Health Cluster) and Gender Based Violence (under the Protection Cluster) in Nepal. The government of Nepal has adopted the cluster system through National Disaster Response Framework (NDRF) in 2013 and identified UNFPA as the co-lead of National Protection Cluster. UNFPA takes the lead in providing supplies and services to protect reproductive health, emphasizing the special needs and vulnerabilities of women and young people. UNFPA Nepal's humanitarian preparedness programme mainly focuses on policy advocacy, planning, capacity development, prepositioning of essential reproductive health and dignity kits and other supplies. The humanitarian response strategy focuses on how to provide timely response on provision of essential reproductive health services and prevention and response to Gender Based Violence (GBV).

Prepositioning of dignity kits is very essential for provision of response to the hygienic needs of women and girls during emergency. Hence, UNFPA Nepal is seeking proposals to establish Long-term Agreement (LTA) with suppliers for the provision of dignity kits.

#### **Objectives**

The main objectives of the LTA is to establish a long term agreement in order to provide supplies according to UNFPA response to humanitarian situations.

#### **Deliverables**

The suppliers will be responsible for the following tasks:

• Supply of specified items as per technical specifications. Amendment/changes might be made in the items of kits.

#### **Activities**

The supplier will be responsible for the following tasks:

- Prepare the bag for packing as per the given specifications.
- Packing of all items in the bag.
- UNFPA Logo to be placed on the bag of each kit and if required, as per UNFPA's advise a UNFPA partner/donor logo will also be requested to be printed..
- Delivery of kits to the UNFPA Nepal only if specifically requested by UNFPA.

#### **Timing**

The selected supplier is expected to have the capacity of delivering 5,000 sets of kits within 7 days from the receipt of UNFPA's purchase order.

#### Work setting

NO item changes are allowed without the notification and approval of UNFPA Nepal. The samples submitted at a bidding stage will be kept for benchmarking purposes and any deviation in the items/content should be immediately communicated for UNFPA approval/review.

#### **Experience and qualifications:**

Three year experience in supplying and delivering similar items to INGOs/NGOs/UN agencies, etc..

#### **Samples**

UNFPA requires product samples for evaluation of the item at the time of bid submission. <u>Samples shall be considered as part of the offer and shall be subject to technical review</u> and laboratory analysis, where appropriate. Samples of items quoted in each category must be provided.

Bids passing preliminary examination shall undergo technical evaluation, which will consist of a specifications review (based on a completed Section V 4. Product Item Overview Form), followed by a physical examination of each sample in accordance with the requested technical specifications.

#### The items of the dignity kit

It depends on the needs of the affected population, hence the items might differ based on scenario and geographical location of emergency. The items given in the 2.2 technical specifications are common items agreed by the Nepal National Protection Cluster.

UNFPA reserves the right to request the supplier to kit the items in accordance to its programme needs - i.e. not all orders will contain the same/all items covered by the LTA.
